
# SIX NATIONS OF THE GRAND RIVER Annual Report

SNGREC engages in political advocacy with international, federal, provincial and municipal governments and organizations, on issues impacting the Six Nations of the Grand River Territory and community.

## **Political Advocacy for the Six Nations Community**

SNGREC engages in political advocacy, with international, federal, provincial and municipal governments and organizations, on issues impacting the Six Nations of the Grand River Territory and community. Additionally, build relationships and raised awareness of Six Nations, and who we are as a distinct people with unique needs.

We have engaged with municipalities on the Haldimand Tract and in our region and built up pressure on the provincial government to fix its consultation rules and requirements in accordance with our community's policies. We are continuing this work, and the end goal is to have consultation and accommodation practices that benefit our people, rather than special interests.

Here at home we have been building up Six Nations' ability to keep our people safe. This

includes renewing the Six Nations Cannabis Commission's work in the community to protect the health and safety of everyone.

In our federal engagement, we have been promoting a solution to the excise tax injustice that results in over \$350 million leaving our community every year to Ottawa, and only a

trickle comes back. This is unacceptable and we are prioritizing this as an issue for the federal government to fix.

#### **Six Nations Sovereignty**

We have continued to build up SNGR as a governing body, and our administrative departments now provide over 120,000 points of service every year to our people.

We have over 900 employees (80% Indigenous, and 78% are Six Nations Community *Members)* are running our organization every day. This government is for our people and by our people.

SNGREC supported administrative and governance structural re-alignment for increased efficiency and community accountability.

SNGREC endorsed community sovereignty

## **Looking Forward**

The future of SNGREC is to continue to show

transparency to the community, as well as advocating for the Six Nations Community at all levels of government, whether it's municipal, provincial, or federal. SNGREC will also continue to advance political and economic sovereignty.

#### **COVID-19 on Six Nations**

SNGREC successfully ensured the continued health and safety of the community through the concluding months of the world-wide pandemic while ensuring community were still able to access services.

SNGREC continued to advance Six Nations Litigation Against Canada and Ontario for the accounting of Six Nations' lands and money, as well as leading an awareness campaign focusing on municipalities within the Tract.

We enhance the quality and efficiency of SNGR programs and services which are based on the needs of the Six Nations community (reviewing current programming, resources, funding as well as program outcomes and evaluating if they are meeting community needs).

### **Looking Forward**

Developing internal supports to enhance employee wellness and implementing standardized service administration processes and procedures including communication pathways, clinical supports, clinical care pathways and identifying service outcomes.

### **Nation Building**

This portfolio of teams led by an executive director supports the organization and community to address gaps in developing community-driven standards, environmental protection measures, and address land use and membership issues. We ensure the organization facilitates better decisions based on community engagement and ensures effective communication that meets the community's needs.

Departments within the Nation Building portfolio include Lands and Resources, Lands and Membership, Justice, Tourism, Mother Earth, Yeriwahron:kas ((They Hear the Matters) role for community complaints and suggestions to be heard and addressed), the Community Engagement Standards Project, and SNGR representative for the Jay Treaty Border Alliance (technical table) and at the Iroquois Caucus.

#### **Looking Forward**

Completion of Community Engagement Standards, structuring the Mother Earth department as well as continued relationship building and to monitor SNGR's ongoing litigation.

## Planning, Performance & Evaluation

This portfolio of teams led by an executive director supports the need of the organization to be more strategic, improve capacity to evaluate and understand the needs of the population, improve program planning and advocacy for service funding, and to ensure that the services being delivered are achieving the intended outcomes/impacts.

#### **Child & Youth Health**

Developed the Haknoseh, Knoha: ah an outreach roles. They have been able to offer numerous land based and cultural learning opportunities for community children and youth.

The Jordan's Principle team supported over 1600 First Nations children and youth, both on and off reserve to meet their unmet social, health and educational needs.

#### **Community Health & Wellness**

A NEW shared space at 1676 Chiefswood Rd - Odrohektageh (A place for gathering) for community programs.

The Dental Services "Dental School Program", sees elementary school aged kids from the Six Nations, to address any oral health needs. The program saw over 250 kids from January to May of 2023, with plans to restart again in September 2023

#### **Mental Wellness**

New extended operation hours of the Crisis Hub for our community that provides services from 8:00 am to 11:00 pm Monday to Friday.

Additionally, as of the 2023/2024 fiscal year, the Mental Wellness Portfolio has been able to eliminate the extensive wait list for access to services.

#### Family & Community Care

One of our part-time physicians began to work full time, allowing the Family health team the *ability to increase capacity to take* on new patients. We were able to take on 125 new clients in the last 7 months

Successful liaison with educational facilities to encourage and increase student rotations within our clinic, focusing strongly on community members and Indigenous Students

## **Looking Forward**

Health Services will be renamed to 'Wellbeing' in the upcoming year, as part of our organization restructuring and will continue to evolve utilizing a lens of culture as our foundation. We will focus on addressing gaps in service, promoting accessibility, and enhancing collaboration and integration to improve care. We will be expanding opportunities for community members to engage and be included in the future of the department.

We are continuing to engage in more collaborative care programs between various Health Services and other Council departments within the Six Nations of the Grand River community. Lastly, a new Youth Drop in space is being renovated and set up are in final stages. The space will offer a staffed safe location for youth. The space will provide access to technology recreation and healthy role models.

We provide rental accommodations for those unable to enter home ownership, and loans for new construction, purchase, and repairs/renovations for those looking to

enter or maintain home ownership. We also offer commercial rental units for local businesses to generate additional wealth and

economic growth for the community.

Development of the Onondaga 2 townhouse (5 affordable units; 3-bed, 2 x 2-bed, 2 x 1-bed) will break ground in Fall 2023

#### **New Duplexes in Development**

Moccasin Trail duplexes (4 x 2-bed units) will be complete in Fall 2023

#### **New Purchases/Built Homes**

38 community members were able to build or purchase a home in 2022

## **Looking Forward**

We are focusing on housing in all forms: emergency, transitional, rental and homeownership. We're hoping that the restructure in alignment with the community plan will allow us to focus on what we do best: getting people housed!

Next, we are looking to identify and separate social housing from market housing, which includes the development of a subsidy and an emergency housing program.

Additionally, we are looking to realign and define the barriers that our members face in moving to home ownership.

## MEET OUR **Justice**

### **Our Purpose**

The Justice Department offers support to victims and those accused of a crime in the regions of Brantford, Cayuga, Hamilton and Six Nations. They work toward providing community members with resources to heal from crime, social tragedy, and the consequences of their intergenerational trauma; and provide alternatives to the mainstream justice system to refrain from further harm. In other words, the Justice Department represents principles of restorative justice and rehabilitation similar to Gladue. Gladue principles are utilized to address Indigenous over-incarceration by looking at intergenerational and historical trauma faced by Indigenous communities like Six Nations.

Justice programs and delivery of services to the community

are guided by Haudenosaunee Legal Principles.

## **How We Service The Community**

- Restorative Justice (RJ): referral from Crown or community
- Indigenous Victim's Services (IVS): referral from Crown, police, community member or an Indigenous person seeking assistance
- Bail Verification (BV): advocacy for Indigenous persons involved with the court system
- Gladue Aftercare (GA): advocacy and follow up for an Indigenous person who has obtained a Gladue Report for their sentencing

SIX NATIONS JUSTICE DEPART

- Family & Criminal Law Information Clinic (FLIC/CLIC): legal advice from a LAO panel lawyer
- Community Standards: update, develop Six Nations laws/ bylaws

#### **Indigenous Victim Services**

Indigenous Victim Services provides case management, safety planning and relocation support for people who have experienced or are experiencing domestic violence.

In 2021/22, IVS provided *5462 points of services* to their clients and provided *149 referrals* to counselling services.

#### **Restorative Justice Program**

Restorative Justice Program (RJP) provides services and support to Indigenous people accused of a crime. In 2021/22, RJP received 205 referrals.

"I learned that no matter, I can be a good person and learn from my mistakes... I have learned self discipline and that there is nothing wrong with asking for help. Just keep moving forward."

## **Looking Forward**

Community Standards program is currently involved in developing laws for Six Nations in draft, for review by Council and the SN community.

Note: priorities include; Child Welfare, Environment, Residency and creation of a court / tribunal on reserve and working on enforcement component.

**Restorative Justice program** is running a pilot project with a SN Elder to ensure RJ principles are delivered in a culturally appropriate manner.

Gladue Aftercare program needs to be paired up with a Gladue writer as these two positions compliment one another and run most effectively as part of a team, who assist and advocate for clients involved at the sentencing portion of their court matter and follow the reintegration process.

*Indigenous Victim's Services program (IVS)* needs additional workers to support the increasing demand for services in the Hamilton, Brantford, Cayuga and Six Nations areas.

Family Law & Criminal Law Information Clinics is a growing program that we operate in collaboration with Legal Aid Ontario (LAO). A new worker is planned to come on board and take over running the program which is planned to expand from one 4 hour clinic per week, to two per week, to meet the increasing community demand.

## MEET OUR Lands & Membership

### **Our Purpose**

The Lands & Membership Department administers all aspects related to membership on for Six Nations of the Grand River. Additionally, the department preserves the integrity of Six Nations of the Grand River's traditional lands by supervising all on-Reserve land matters as requested by our members. All services are done in a professional respectful manner to the public we service.

SNGR is the largest populated First Nations in Canada with a total population of 28,569 registered members. Our department has the highest volume for land registration instruments in the Indian Lands Registry and the highest number of registered survey plans of any Reserve

in Canada.

- Applications (membership, internal/external band transfers, family tree searches, blood quantum letters, and Event Reporting, such as reporting such as birth, death, marriage, name change, change in custody, residency.)
- Status Card First, Renewal and Replacement Cards (only Laminated Certificate of Indian Status Cards). For the Secure Certificate of Indian Status cards (white plastic cards issued directly by ISC) staff will review and assist those applicants to ensure no rejections.
- Permits/Leases with third party entities that provide service to the community

- Lands General Services (all land transfers, surveys, agreements to all Right of Ways, residency letters, general information on Estates such as contact names at ISC, and verifications)
- Lands Data Services (mapping services, property verifications, aerial imagery for community members, Land research services, Certificate/Survey Plan prints)
- Hydro Agreement and payments to eligible members
- Advocating on Jay Treaty Border issues
- Residency By-Law Process

#### **GIS Services**

Continually expanding service to include not only members by request, but also the departments of the SNGR as a whole.

Now has a *comprehensive data set of infrastructure* captured on desktop and online versions of ArcGIS software.

#### **Assisting and Serving the Community**

Assisted in over *50 land surveys* in 2022/23 fiscal year, thereby assisting the community with their planning of their lands.

*623 registrations* in the Indian Land Registry system in 2022/23 fiscal year.


#### **Membership Services**

## MEET OUR Lands & Resources

### **Our Purpose**

Lands & Resources advocates for Six Nations territory and beyond, this includes environmental protection and enhancements, environmental assessments for development applications and more. Additionally, they advocate for *placemaking efforts* that celebrate our Haudenosaunee identity through culture and tradition. They also promote the correct history be told and included across treaty areas of Six Nations of the Grand River.

Completed a *fish census* of McKenzie Creek

Providing *rabies bait distribution services* via the MNRF to prevent rabies sickness

Facilitated *treatment for Spongy (LDD) Moth* – an invasive species, in 2022 and 2023 (i.e., increasing biodiversity).

In progress a targeted study on *aerial insecti vores* (assessment of species and habitat status). Note: They have received funding for two more years to complete this.

Received or in the process of capacity funding agreements with MTO, Metrolinx, for EA's, etc.

Working on several draft accommodation agreements including the first for aggregates with Brant Aggregates agreeing with 10 cents a ton.

Convincing proponents to go beyond the minimum environmental enhancements and to do the 10:1 tree replacement ratio

#### **SNGR Litigation Update**

HDI was denied intervenor status; MCFN was allowed in with restrictive conditions

SNGR were successful on their pleadings amendment, Canada's cross motion was dismissed.

SNGR to be receiving costs for both motions.

The trial is to commence in the latter half of 2024.

## **Looking Forward**

We will continue with the litigation until either after the trial is finished or negotiations are complete.

We are looking to reach other claims, and other litigations (example: Brantford, etc). Lastly, building capacity to assist the Archaeological unit.

Successfully planned and coordinated weekly client workshops. The goal of our workshops is to enhance a client's knowledge and skills that will lead to independence. Our department also has provided clients with transportation services to participate in our workshops.

The opening of this facility was delayed due to the COVID-19 Pandemic.

#### **Four Facility Improvement Projects**

Ontario Trillium Foundation provided grant funding for four (4) facility improvement projects. The projects are:

- 1. Replace the rink boards at the Sports and Cultural Memorial Centre
- 2. Install LED lighting at one of the softball diamonds
- 3. Install sliding doors at the entrance to the Dajoh
- 4. Replace the fountain with a water bottle fill station at the sports fields.

All of these projects will be completed in 2023. Thank you to the Ontario Trillium Foundation for the grant funding for these projects.

#### **New Rock Climbing Activity for Youth!**

Rock Climbing Ontario approached Parks and Recreation in early 2022 about teaching the rock climbing activity to children. This program has been offered on a regular basis and has been filled to capacity each time. Rock Climbing has become a popular activity with community residents.

## **Looking Forward**

Within the new restructuring plan for the Elected Council departments, Parks and Recreation has been placed under the category called Community. This categorization is very appropriate, because the Department has always worked closely with the community (through recreation facilities, program sessions and annual events) and will continue to do so in the future.

Developing safe community parks for families while preserving and promoting history of the schools and cultural identity.






